LEARNING, TEACHING AND ASSESSMENT INFORMATION

6a. Module Description

This module explores the appeal of contemporary popular cinema and builds on the critical ideas and theories you have already studied in previous years of the film studies program. By examining current debates in the field of film studies, you will be encouraged to engage deeply with film theory and get a better understanding of the impact and meaning of popular cinema.

We will define and critically discuss the nature of popular cinema and how multiplex culture has grown in places like North America and the UK. Key topics will include: the pros and cons of the multiplex; analysis of dominant genres and conventions; consideration of the recyclable nature of popular film narratives; the depiction of gender, sexuality, 'race' and class on screen; audience and spectatorship; representations of violence; the rise of the blockbuster and star studies.

The module considers the force of popular cinema as an important site for working through societal fears and fantasies by closely examining a variety of films, from, for example, Jaws (Spielberg, US, 1975) to Titanic (Cameron, US, 2000).
