6a. Module Description

In the Sociology of Health Inequalities module, you will examine the interaction between health and society, particularly the relationship between health and social inequality. The vulnerabilities, strengths and differences between human bodies are experienced by all of us but the health outcomes, life expectancy and vulnerability to infectious disease varies because of poverty and inequality. You will look at how disability and ideas of the “healthy body” relate to neoliberal notions of individual agency and personal responsibility, often serving to legitimise forms of marginalisation and inequality. You will also examine the ways in which medicine has been racialised. You will be taught by lecture and interactive learning sessions, and you will be required to engage with written and visual sources and numeric datasets for learning on this module. Within this learning environment, you will assume collective responsibility for applying course material to a specific topic in order to generate sociological understandings of health and inequality. You will be encouraged to engage with some challenging themes, thus building on a set of adaptability skills that will also create opportunities to engage with the wider university structure, and thus develop social capital.
