Begin your studies by gaining an overview of public health and understanding how it aligns itself to the medical and social sciences. You'll jump right into understanding how community life might affect the health of the people living there. Drawing on current Public Health issues you'll develop an understanding of the types of factors that can impact individual health such as social inequalities (access to education, resources and support). You'll analyse your data using different software programmes and understand different sections of society and health differences.

You'll begin developing your skills as a public health practitioner, recording your journey via an e-portfolio to prepare you for your future career, and possible registration with the UK Public Health Registry.

E:Portfolio: including CV, SWOT analysis, PDP, reflection on what is means to be a public health practitioner, and evidence of engaging in a "Live Brief" developing a solution to a Public Health issue reported in the media with consideration to ethical issues.
