6a. Module Description

The content of the module will focus upon the specialist knowledge and the clinical skills that are required to enable the student to competently undertake a thorough physical examination of the newborn and infant in clinical practice. The student will utilise in-depth knowledge and understanding that they have gained to enable them to recognise the deviations from the normal to initiate appropriate care and referral.

Critical analysis with synthesis of relevant research reflection and completion of the practice documents will allow students to further identify their learning needs and develop their scope of professional practice. Students need to work in the appropriate clinical environment to undertake the Newborn and Infant Physical Examination (NIPE) under the supervision of a health professional with the NIPE qualification as a pre-requisite of the module.
