6a. Module Description

In this module you will survey the history of English Literature between William Blake and the present day. Mainly using Volume 2 of *The Norton Anthology of English Literature* you will study period, genre and form through a range of texts including: the novel; the short story; the essay and manifesto; poetry; drama; letters and graphic art. You will develop your analytical skills as well as your abilities in communicating the research and analysis that you will apply to the literatures under discussion.

Working with other students in class you will develop your social capital and critical skills in whole and small group discussions. You will develop your sense of identity as a critical and adaptable thinker, problem-solver, researcher and creative agent as you apply theoretical material to the primary literatures under discussion. You will also realise the broader social and cultural capital of the course as you engage with key ideas and concepts related to, but also transcending, the literatures under discussion.

6b. Outline Content

- English literary history from the present to the French Revolution
- Sample texts by major authors (Blake, Tennyson, Conrad, Woolf, T.S. Eliot, Achebe)
- Consideration of how the 'canon' of English literature is formed
- Knowledge of different ways of periodising English literature such as 'Romantic', 'Victorian', 'Modernist', 'Postmodernist', 'Postcolonial'
- Understanding of individual texts in relation to a historical and cultural context
- Close reading and taking notes
- Research – finding and evaluating critical material
- Argument – integrating your own ideas with those of others
- Essay, paragraph and sentence structure
- Drafting – clarity and word choice
- Bibliographies and referencing
