LEARNING, TEACHING AND ASSESSMENT INFORMATION

6a. Module Description

The module explores global cinema from 1895 to today. Traditionally, the history of cinema has privileged mainstream cinema from the US and Europe with a sprinkling of 'world cinema'. By contrast, this module introduces you to a global and transnational approach in which Hollywood forms one part of the globalised commercial and artistic film landscape of the last 130 years. We study a range of films from Europe, Africa, the Middle East, the Americas, South and East Asia, and the Pacific region. We trace the origins of today's industries, from film-makers as artisans to Hollywood, Bollywood, Nollywood, and art-house cinema. The focus throughout is on the distinctive filmic aspects of cinema (style and other formal aspects, technology, the

industry) and how these have interacted with wider historical and geo-political developments. Specific topics for focused study may include indigenous cinemas, the representation of violence and war, the representation of gender and sexuality, the development of genres, and other current topics. You will encounter films made by women, films that are blockbusters, as well as films that may seem obscure or 'niche'. You are encouraged to think historically and critically, and to reflect on your own situatedness with regard to films from long ago and 'far away'.

The module is designed to enhance your ability to meet professional and employment expectations, such as clear communication, and the ability to work independently and to meet deadlines. The module also addresses ethical values, encouraging you to be address issues of diversity and inclusiveness.
