LEARNING, TEACHING AND ASSESSMENT INFORMATION

6a. Module Description

This module explores a set of urgent issues in the context of contemporary media, focusing on 'fake news', conflict and law. The first part of the module explores different definitions of, as well as contemporary discourse around, 'fake news', before addressing specific examples of this phenomenon. The module considers 'fake news' from a range of perspectives, including politics, technology, and journalistic practice. The module explores possible ways of offsetting the problem of 'fake news'. The module then turns attention to representations of war and conflict in media, and specifically how different media forms have sought to stage and document social conflict. In this context, the module addresses a range of media depictions of war and conflict across inter alia print, sonic and audio-visual forms. Examples will be drawn from British and international contexts and from contemporary and historical settings. The third and final part of the module explores specifically legal issues surrounding the creation, use, consumption, and circulation of media. These includes an address to intellectual property rights, offering a detailed survey of copyright, trademark and patent law with a special emphasis on how they apply to media. The module also considers issues of privacy, surveillance and cybercrime. Overall, then, the module provides students with a clear understanding of a set of urgent, and related, issues in relation to contemporary media.

6b. Outline Content

Through reading of critical texts, analysis of sources, class discussion, and the reviewing of important examples, students will engage with debates around 'fake news'; concepts of 'post truth'; examples of 'fake news'; possible solutions to the 'fake news' crisis; questions of representations of war and conflict; analyses of media reports of war and conflict; questions of media law; knowledges of intellectual property law (copyright; trademark; patent); analysing cybercrime; understandings of privacy and surveillance.
