6a. Module Description

Ethics is all about making decisions based on what you consider to be correct and not correct. Ethics makes you ask questions about claims in order to better grasp the nature of acceptable principles in behaviour and treatment. With these ideas, you will cover areas in reference to psychology, technology, education, business, and the medical and legal fields.

In this module, you will investigate competing answers to an idea and critically engage with them to examine their strengths and weaknesses with regards to ethical questions. You will gain a broad understanding of how ethics can be applied to a variety of subject areas and what questions should be asked to evaluate validity.

This module seeks to consider and critique different principles and theories about ethics. On this course, you will investigate the status of several major ethical theories and claims and consider some practical ethical issues (such as global poverty and animal welfare) which are impacted by these theories. At the end of this module, you will be able critically think about potential ethical dilemmas and engage with different value systems

6b. Outline Content

This Module will serve as an introduction to ethical philosophy in general and to philosophical ethics, with particular consideration of the positions of thinkers commonly associated with these areas such as (but not limited to):

Kant, Aristotle, Marquis, Kelsen, Rawls

Students will learn to recognize ethical arguments and to assess them critically for differing viewpoints:

- · Ethics in University
- · Ethics in the Humanities
- Ethics in Science and Psychology
- Ethics in the Medical Field
- Ethics in Law
- Ethics in Business
- Environmental Ethics
- · Nursing and Social Work Duty of Care

Students will gain practice in employing the tools of critical analysis in their thinking and writing, using resources to support an ethical viewpoint.

Students will learn to conduct research and study with an ethical perspective and to organize the findings of this research for effective communication within the University setting with a view to the career world by:

- Analysing case studies
- Applying ethical strategies
- Creating an Ethics Proposal
