6a. Module Description

Public Law (sometimes referred to as Constitutional and Administrative Law) is all about legal power: where it is located in the British constitution and how and by whom its use is scrutinised and checked. This module is fundamental to those considering a career in the legal profession, and provides a broad framework in which all other areas of substantive law operate, whilst also reflecting on the historical development of liberal values and contemporary notions of citizenship that underpin modern British society and values.

Initially you'll focus on the constitution of the United Kingdom, providing you with a solid foundation in the main structures, relationships and themes in domestic constitutional law. You will also look at the law and institutions of the EU, and this includes the historical and current relationship with Member States and within the English legal system.

After considering these key areas, you will move on to administrative law and related matters. The focus will be on the main non-parliamentary ways in which decision-makers are held to account and will involve looking at inquiries and ombudsmen and the important function of judicial review which you'll examine through authentic, real world case studies. Finally, you'll be introduced to human rights and civil liberties, particularly the substance and impact of the Human Rights Act 1998 and its place conceptually and practically within law.

In addition to the study of the above as academic components of legal studies, this module is designed to reflect necessary elements required by the Bar Standards Board (BSB) and Solicitors Regulation Authority (SRA).

6b. Outline Content

Indicative content aligns with requirements of the BSB and SRA, taking into consideration developments by, and requirements of, these professional bodies insofar as possible. Content will therefore include, as a minimum:

- The UK constitution and doctrines
Constitutional meaning and scope; Sources of Law: Principles and doctrines,
- Parliamentary supremacy and parliamentary sovereignty
Authority of Parliament and the roles and functions; Legal application of sovereignty; Implications of supremacy and Sovereignty of EU Law
- The role of the executive and the Crown
Rule of law; Separation of Powers; Royal Prerogative and the Judiciary
- Public Law
Functions and developments; Legal and Administrative Justice; Court structure (including tribunals, inquiries and ombudsmen)
- Judicial review
Grounds; Expectations, limitation and relief; Remedies and Procedures; Public authorities
- The Equality Act and Citizens' rights
Rights; Exceptions and principles; Legal Procedure
- EU Law
Development, Institutions and Decision Making; Direct, indirect and primacy of EU Law; Free movement of goods and workers
- The European Convention on Human Rights and the Human Rights Act 1998
ECHR; HRA 1998; The approach and scrutiny
