6a. Module Description

You will be introduced to key concepts in English law and the skills you will need to be successful in the LLB and later use in your career.

The key theme running throughout the module is that law is dynamic, and the study skills are pervasive.

The concepts you will cover are, the sources of law and Statutory interpretation, the structure of the legal system, the civil legal system, the criminal legal system, access to justice, the future of law.

The transferable skills that you will obtain will be legal research (such as fact handling and case reading and Informational literacy), group working skills (such as advocacy and negotiation), enhanced communication skills (both written and oral), interviewing skills, digital and analysis skills.

4. Understand the theory and practice of skills for law including research, communication skills, writing, analysis, advocacy, interviewing and negotiation.
