6a. Module Description

This module will provide you with the opportunity to examine a real-life, current legal issue and undertake a theoretically informed analysis, resulting in recommendations and considering the practical implications for implementing these recommendations.

Drawing on knowledge, skills and tools gained from across your programme of study, you will undertake a secondary research project to critically assess a legal issue and formulate recommendations for practice. You will engage with relevant literature to identify, examine, analyse, interpret and synthesise relevant data from multiple sources.

6b. Outline Content

This independent research project offers you the chance to choose your own topic aligned with your interests and aspirations. It serves as a platform for showcasing your mastery of the skills you've developed during your degree, including the ability to learn, conduct research, critically assess information, solve problems, communicate effectively, maintain precision and credibility in your work and most importantly to do so autonomously. It is also an excellent employability tool to demonstrate to future employers your interest in a particular area of law.

This module has four briefing sessions and a range of research training screencasts. You will also be allocated a dedicated supervisor to assist with your Major Project and will have 4 hours of individual supervision. The role of the supervisor is to assist you by providing advice and guidance on how to prepare, produce and improve your dissertation, e.g. guidance on the clarity and coherence of your arguments, the overall structure of your paper, the feasibility of your chosen topic.
