## LEARNING, TEACHING AND ASSESSMENT INFORMATION

### 6a. Module Description

In this module you will study how nineteenth-century literary texts respond to environmental change. A popular theory is that the Anthropocene (when human activity started to have a significant impact on the planet) began in the 1800s, a time that saw huge industrial transformation. We will trace the literary responses to global and mass industrialisation and to climate events such as the year without summer in 1816, following on from the eruption of Mount Tambora in 1815. Moving through texts in roughly chronological order, you will consider the emerging understandings of nature and the environment in Victorian novels and poetry before turning to fin de siècle apocalyptic writings. Through the module, you will learn to evaluate the field of ecocriticism and to integrate approaches and lenses as you assess the significance of reading nineteenth-century texts in a time of climate emergency.

### 6b. Outline Content

Topics for study will include:

- Literary responses to the natural world and to climate events
- Environmental writing by women and less well-known authors
- Nineteenth-century literature and globalisation, particularly connections between imperialism and the environment
- Writing about climate change
