6a. Module Description

Building on work you have done at Level 4, this Level 5 module examines ways of thinking about the social that are 'critical' in that they, in a variety of ways, challenge or decentre taken-for-granted assumptions and structures. In doing so it will consider the ways in which knowledge of the social world is itself political.

The module will show you how social theory can be both challenging and useful. The module is organised around four themes:

- Bourdieu and beyond: knowledge, culture, and the reproduction of inequalities
- Intersectional approaches to social divisions
- Humanity 2.0? Self, embodiment, and enhancement
- Reassembling the social: encompassing non-human actors

You will develop your understanding and confidence of theories through close reading of primary texts. In the latter stages of the module, you will have opportunities to apply the concepts and approaches we have learnt to real world issues in a series of theory mapping workshops.
